Water Awareness Breakfast

To help welcome April as Water Awareness Month, our League hosted a very special breakfast in honor of legendary League member and "water warrior," Dorothy Hores. Barbara Litrell spoke in tribute to Dorothy's passion in her work to raise awareness of the need for water conservation and sensible water management practices in Northern Arizona. Our moderator and speaker for the morning was former State Senator Tom O'Halleran. He first presented "Water Warrior" awards to three local people who have been at the forefront of numerous battles to conserve water resources in the Verde Valley region. This year's three awardees were Yavapai County District 3 Supervisor Chip Davis, former Camp Verde Mayor Tony Gioia, and former Sedona Mayor Dick Ellis. League president Fran Levengood also presented an honorary award to Tom O'Halleran. Tom's talk was an explanation of the Verde River Basin Partnership and an appeal for public support. Federal funding is needed for scientific studies to determine just how sustainable the water supply in the Verde Basin might be, given the growing demands for water and the sad history of depletion of other rivers and watersheds in Arizona. The talk was both enlightening and sobering - a call to action for all of us to make our views known about the kind of future the Verde River is to have.
