#### **Proposed Amendment to LWVSVV Bylaws, required by LWVUS**

(Words in **bold face** are to be deleted)

ARTICLE III. Membership

Sec. 2. Types of Membership

Voting Members. Citizens at least 18 years of age who join the League shall be voting members of local Leagues, state Leagues and of the LWVUS; (1) Individuals who live within an area of a local League may join that League or any other local League; (2) those who reside outside the area of any local League may join a local League or shall be state members-at-large; (3) those who have been members of the League for 50 years or more shall be **(honorary)** members excused from the payment of dues.

*(Reason for Amendment: The bylaws of state and local leagues must conform to the first three Articles of the LWVUS bylaws. At the 2010 national convention, the above bylaw was changed when the word **honorary** was deleted. This was done because delegates felt that these longtime members were "regular" members and were not given "honorary" membership.)*

## REPORT FROM STATE LEAGUE

### ***President's Perspective***

This Newsletter is all about the LWV/AZ Convention on Saturday, May 21 and Sunday, May 22 at the Windmill Inn in Surprise. There are reports on the budget, the nominations, the bylaws, and program items.

The plenary session on Saturday morning will deal with these reports. Immediately after lunch on Saturday, Tara Jackson of the Arizona Town Hall, will talk about civil discourse on controversial issues. In the afternoon, we will have workshops on activism, social media, fundraising, and League training. Our dinner speaker will be The Honorable Robert Brutinel, Associate Justice of the Arizona Supreme Court. He will speak about our very successful merit selection of judges. After dinner, we will have a caucus on ranked choice voting and a discussion on local League activities.

On Sunday, Elaine Wiant, our liaison from the LWV/US, will conduct a workshop on nonpartisanship. Linda Valdez, columnist for *The Arizona Republic*, will speak on some aspect of immigration. Finally, we will adopt a budget and program items, elect officers, and transfer the gavel to the new president.

I very strongly urge League members to attend part or all of the Convention, if you are able to do so.

## LWVUS Sets Legislative Priorities for 2011

The national League board has adopted the following LWVUS Legislative Priorities for 2011: Clean Air Defense; Health Care Defense; Money in Elections (campaign finance reform); and Voter Registration and Election Administration. The Legislative Watch List\* is as follows: CEDAW (Convention on the Elimination of Discrimination Against Women); Climate Change; Ethics; Immigration; and Safe Drilling and Mining ("Fracking").

*\*The Watch List means that if an opportunity arises on these issues and does not interfere with action on an advocacy priority, the LWVUS may take action if it appears we can make an impact.*

The Board discussed many issues and the responses from members suggesting Legislative Priorities. The decisions were made based on what issues are likely to come before the 112th Congress, the opportunities to make an impact, program decisions made at the 2010 Convention, member interest and resources available to manage these priorities effectively. The Board reviews these priorities throughout the year, making changes if warranted.
