<u>Independent Judiciary to be Topic of Annual Meeting Keynote</u>

The LWV of the United States has been working to promote the importance of fair and impartial courts nationwide; included in this support is encouragement and funding to State League campaigns for merit selection of judges (as opposed to elected judges) and for more diversity on the bench.

Sandra Goodwin, a member of our neighbor league, the LWV of Central Yavapai County, will be the speaker at our annual meeting on May 11th. She is the Arizona League's Director for Impartial Courts. Sandra is an eloquent speaker; we are privileged to have her visit Sedona to present on this subject.

The following is the position that the League of Women Voters of Arizona (LWVAZ) has taken regarding "Judicial Selection and Tenure":

The LWVAZ supports the selection of judges by appointment, with voter approval for retention; adequate judicial salaries; longer terms; higher qualifications for justices of the peace and magistrates; a judicial nominating commission, responsible to the governor; and a competency review commission.

To assure that our judges are free of political bias and possessed of the proper qualities of temperament and intellect, and yet retain ultimate control of the courts in the hands of the people, The League of Women Voters of Arizona supports:

- 1) Appointment of judges by the governor from a list of qualified nominees submitted by a bipartisan commission of legal and lay members.
- 2) Retention of a judge in office, after an established period of time, only by a "yes" vote of the people, a "no" vote requiring a new appointment by the governor.

(This system of judicial selection and tenure has been adopted for Pima and Maricopa counties and is optional for other counties. Although we have basically accomplished our goal, we retain the position because in each session of the Legislature, there are efforts to return to the old elective system.)

<u>Grow Local --- Buy Local: Enhancing the Quality of Life in the Verde Valley Region</u>

League members and others who attended our April 11 program on new local agricultural initiatives in the Verde Valley were treated to a wealth of information on how our region might again become "the breadbasket of Northern Arizona."

Robyn Prud'homme-Bauer led off the evening by explaining the League's history of education and advocacy concerning agricultural issues. The national League's 1988 policy position is being updated this year. In general, the League believes that federal agriculture policies should promote adequate supplies of food and fiber at reasonable prices to consumers, farms that are economically viable, farm practices that are environmentally sound, and increased reliance on the free market to determine prices. Of the specific policies supported, the League believes that the most essential for the future of agriculture are: encouraging sustainable agriculture; providing research, information and technical assistance to agricultural producers; and free market principles. The LWV policy update will focus on today's technology issues such as genetically modified organisms (GMOs), herbicides, pesticides, sustainable farming, water pollution, aquifer depletion, antibiotics in livestock, and accurate food labeling. It will also address finance issues, consolidation in agriculture industries, and the federal regulatory process.

The themes of the evening's program on local initiatives tied in nicely with the League's interests and policies. <u>Linda Buchanan</u>, Interim Chair of the Verde Valley Agricultural Coalition (VVAgC), led a panel of experts in describing the mission of the coalition, the Food Hub concept, and their vision of a renaissance of agriculture in the Verde Valley. The Coalition's principles include: Wise land use, Sustainability, Food Safety and Security, Quality of Life, and Water Management. We should be concerned because hunger exists and because "Everyone eats so we are all stakeholders."

The first speaker was <u>Debra Emmanuelle</u>, Executive Director of the Verde Food Council; she is also founder and CEO of Green Papillon, a greenhouse business, and serves on the Arizona Hunger Advisory Council. She talked about hunger in our

region, noting that in the Verde Valley 15,000 people in a population of 65,000 are affected. Child hunger can lead to learning disabilities, and thus has an impact on education. Though we in the U.S. are fortunate not to have the starvation that occurs elsewhere, there is widespread malnourishment. On the upside, there are movements everywhere to promote clean, good food and sustainable agriculture. She sees such a movement here, and also the prospect of job creation through "growing local"; she would like to see local, healthy food affordable and accessible to everyone.

Bernadette Selna grew up here, taught at Clarkdale Elementary, and is described as "a tireless champion of things green and growing." She is a founding member of the VVAgC. Bernadette explained the idea of a Food Hub. Over 160 Food Hubs now exist in the United States, mostly in the north and north-central regions but they are spreading nationwide; there is now a food hub in Phoenix. Each one is unique to the needs of its specific area, but basically they are a central place to bring together producers, distributors, and marketers – a "connection place" similar to a FEDEX hub – to coordinate the movement of primarily locally/regionally produced foods from multiple producers to multiple markets. Food hubs help to ensure that the growers are providing products that the consumers want, need, and can afford; they also work to be financially viable while having positive impacts within their communities.

The next speaker was <u>Casey Rooney</u>, who is the Economic Development Director of the City of Cottonwood. He sees three goals of economic development: create jobs; create wealth for the community; and enhance quality of life. He wants agriculture to be one of the focus areas in seeking to reach these goals. We are seeing success in building our local wine industry; why not try to do the same with other types of agriculture? Rooney has been pushing this idea through local forums and has garnered quite a bit of support. He notes, however, that there are obstacles such as competition from other interests for water rights.

Mary Chicoine, President of the Verde Valley Regional Economic Organization (VVREO), was the final speaker. The VVREO is highly respected for its selectivity in choosing projects and for its dedication to working collaboratively with regional partners. Her group has now identified agriculture as an economic driver for our region and a critical component of what the Verde Valley IS. She pointed out that agricultural interests could use some favorable legislation in a number of areas, so there need to be activists and organizations willing to lobby for action. Examples of some recent initiatives include a propose to amend Clarkdale's Zoning Code to include a policy statement supporting local sustainable agriculture, a State law passed last year that removes obstacles to the donation of Arizona-grown food crops to charities, and a provision of the federal American Tax-Relief Act that extends incentives for the donation of food and grocery products from small businesses to food banks.

A short Q&A session followed the presentations, but could not begin to satisfy curiosity about all that had been covered in such a short time. You can be sure that we will be hearing much more on this topic in the future. Anyone who is interested in learning more – or becoming involved in the effort – can check out the website of

<u>League of Women Voters of Arizona</u>

LWVAZ Convention will be held on May 18 and 19 at the Sheraton Tucson Hotel & Suites in Tucson. Our League can have 3 delegates- so far we have one. The recommended program is State and Local Finances, a study of state and local revenues sources and allocation of revenues. Our League has agreed to lead the study if it is adopted at the convention. If any of you are interested in this topic and like to be a part of the study committee – Robyn would like to hear from you!

LWVUS Action Alert: Senate to Vote on Gun Control Legislation

For months, our nation has debated the laws governing the use of guns and ammunition in our country. It's clear that the majority of Americans want Congress to take new strong steps to relieve the epidemic of gun violence across our nation.

Following its recess, the Senate will vote on S. 649. Tell our Senators it's time to stop the violence. The League has been lobbying for common sense solutions to gun violence that will protect our children and our families and help restore public confidence.

S. 649 will require background checks on all gun purchases and impose stricter penalties for "straw purchases," where one individual buys for another. There will also be amendments from the floor of the Senate that the League strongly supports. These amendments include Senator Feinstein's Assault Weapons Ban and an amendment to limit the size of high capacity ammunition magazines.

Millions of Americans are at risk every day from senseless violence. Responsible gun legislation is a critical matter of public safety and public health. Tell our Senators this issue is too important to ignore any longer and that common sense solutions to gun violence will save lives.

The League of Women Voters has had a policy position on gun control since 1990; now is the time to use it.
