League Recommendations on the State Ballot Measures

The League of Women Voters of Arizona has taken a stand on 3 state ballot measures on the November ballot. The League's recommendations are based on positions that come from member discussion and consensus. LWVAZ recommends a **NO** vote on Proposition 115 – Judicial Election, a **NO** vote on Proposition 121 – Open Elections/Open Government, and a **YES** vote on Proposition 204 – Quality Education and Jobs. Voter Registration/Sandra Day O'Connor Voter Engagement Project

LWVGVV Voter Registration Chair Evie Rowland worked with Patti Prince of the O'Connor House Project to register voters during the months leading up to the fall elections. This effort was kicked off by a registration training session at the Sedona Public Library in May and included **19 voter registration opportunities** for the public in Clarkdale, Sedona, Cottonwood, and the Village of Oak Creek. Member Information

The LWVGVV Board of Directors met on October 18th to discuss current activities and to continue planning for the rest of the year.

Recent and Current Activities: Candidate forums for State Legislative District 6 took place in Cottonwood on October 18th, and a forum for Yavapai County District 2 Supervisor was held a week later on October 24th. Because the candidates were not available, the League was unable to provide forums for U.S. Congressional Districts 1 and 4. We distributed 2,500 printed copies of the LWVAZ Voter Guide on ballot propositions throughout the greater Verde Valley and Flagstaff; they can also be accessed on our website. Evie Rowland chaired our voter registration activities, which began in the summer and continued until just before the last day to register. The Board is taking the necessary actions to incorporate our league as a nonprofit 501(c)(4). Since we are frequently approached by other organizations to cosponsor events with them, the board has adopted a new policy which establishes the criteria we use to decide when co-sponsorship is appropriate. It was decided that the sponsoring group must have a purpose that is consistent with the League's mission; the activity or event concerns an issue that is a current League priority; and the activity or event itself must be nonpartisan, involving no endorsement of a political party or candidate.

<u>Planning</u>: We will hold our annual fundraiser, the Anniversary Luncheon, on Thursday, February 14, 2013. (The League's actual birthday does fall on Valentine's Day.) Forums for municipal primary elections will also take place in February 2013. We also intend to present a public educational program about the selection and retention of judges in Arizona in April 2013. Finally, we conclude the year with the annual business meeting of the membership; this normally takes place in early May.

Next Board Meeting: The November meeting of the LWVGVV Board will take place on Thursday, November 15th, at 2:00 at the Sedona Shadows Clubhouse. All

members are invited and encouraged to attend these meetings. The Sedona Shadows community is located at 6770 W. SR89A (next to Sedona Pines resort between Sedona and Page Springs). After you make the left turn into Sedona Shadows, follow the signs to the office and the meeting rooms are behind the swimming pool.

New Format for Website: League Easy Web, the provider of our website template and software, has revamped all of the local and state league websites that use its services. This was done to make them resemble the recently updated LWVUS website. So our site has a new look, though is still using its old URL; find us at www.lwvsedona-verdevalley.org. We will be tweaking the contents a little to go with the new format. The name change to LWV Greater Verde Valley should be happening soon.

League of Women Voters of Arizona Charter School Concurrence

In early October, all members should have received by e-mail, along with the October **Voter**, a paper describing the Tucson League's two-year study of public charter schools in Arizona. There were also a copy of the Executive Summary of the study's findings, and a form stating the Tucson League's positions. At the bottom is a form for LWVGVV members to sign and return by November 15th, indicating whether or not they concur with Tucson's Charter School Position. (At the State League Convention in 2011, it was agreed that the study and the positions should be submitted to <u>all</u> of the local Arizona leagues for concurrence.) Depending on the information returned by the local leagues, the existing State League positions on charter schools may be expanded.

We plan to have a discussion of this concurrence at the November 8th Wine O'Clock party in Sedona. Members who are unable to attend that discussion are encouraged to read the materials and return the form as individuals.
